#### Strategic Intervention Board (SIB) at Hogarth Primary School

Following a Local Authority commissioned review of governance, Essex County Council issued a warning notice on 23 April 2021 under Section 66 of the Education and Inspections Act 2006 that the right to a delegated budget had been suspended with immediate effect.

The reason for the statutory intervention is as follows:

*There has been a serious breakdown in the way the school is managed or governed which is prejudicing, or likely to prejudice, such standards of performance*

Use of Section 66 of the Education and Inspection Act 2006 removes the authority of the Governing Body to take staffing or financial decisions and allows the Local Authority to have control over staffing and spending decisions to secure improvements.

Essex County Council has therefore taken responsibility for such decisions and all financial, staffing and strategic matters will be fully discharged by the Statutory Intervention Board on behalf of the Local Authority.

Whilst the Governing Body will continue to meet, it may not take any decisions about the management of the school budget or staffing matters.
